

# Terms of Service

## 1. Definitions

In these Terms of Service (hereinafter "the Terms"), the following definitions apply:

- **"Service"** means the URL shortening web application operated at trimy.link.
- **"Operator"** means the individual or entity operating the Service, contactable at trimylinkapp@gmail.com.
- **"User"** means any natural or legal person who accesses or uses the Service.
- **"Short Link"** means an abbreviated URL generated by the Service that redirects to an original URL provided by the User.
- **"Content"** means any URL, data, or other material submitted to the Service by the User.

## 2. Acceptance of Terms

By accessing or using the Service, the User agrees to be legally bound by these Terms in their entirety. If the User does not agree to these Terms, they must immediately cease use of the Service. These Terms constitute a binding legal agreement between the User and the Operator.

## 3. Description of Service

The Service provides URL shortening functionality, enabling Users to generate Short Links that redirect to original URLs. The Service is provided free of charge in exchange for the User's agreement to view one advertisement upon each new Short Link creation, subject to the rate-limiting provisions set out in these Terms.

The Operator reserves the right to modify, suspend, or discontinue the Service (or any part thereof) at any time without prior notice.

## 4. User Obligations and Prohibited Use

4.1 The User warrants that all Content submitted to the Service complies with all applicable laws and regulations.

4.2 The User is expressly prohibited from using the Service to generate Short Links that direct to, facilitate, or promote any of the following:

- Content that is unlawful, fraudulent, defamatory, obscene, or otherwise objectionable;
- Malware, ransomware, spyware, phishing pages, or other malicious software or content;
- Scams, deceptive schemes, or content designed to mislead recipients;

- Content that infringes upon the intellectual property rights of any third party;
- Unsolicited bulk communications (spam) of any kind;
- Content that incites hatred, discrimination, or violence on the basis of any protected characteristic.

4.3 The Operator reserves the right, at its sole discretion, to disable any Short Link at any time and without prior notice, including where the Operator reasonably suspects a violation of these Terms.

## **5. Advertisement Requirement**

The Service is funded by advertising revenue. As consideration for use of the Service, each User is required to view one (1) advertisement upon each new Short Link creation within a given clock hour. Short Links will not be generated prior to completion of the advertisement view. The User acknowledges and accepts this requirement as a condition of use.

## **6. Link Expiry and Data Retention**

All Short Links generated by the Service are subject to automatic deletion sixty (60) calendar days following their creation. The Operator provides no guarantee of availability or longevity beyond this period.

The User acknowledges that the Service is not intended for use cases requiring permanent or long-term URL redirection, and assumes all risk associated with reliance upon a Short Link beyond the sixty (60) day retention period.

## **7. Intellectual Property**

The User retains all intellectual property rights in the Content they submit. By submitting Content to the Service, the User grants the Operator a limited, non-exclusive, royalty-free licence to store and process such Content solely for the purpose of providing the Service.

The Service, including its design, code, and branding, is the intellectual property of the Operator. The User may not copy, reproduce, or redistribute any part of the Service without prior written consent.

## **8. Disclaimer of Warranties**

THE SERVICE IS PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS WITHOUT WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. THE OPERATOR DOES NOT WARRANT THAT THE SERVICE WILL BE UNINTERRUPTED, ERROR-FREE, OR FREE OF HARMFUL COMPONENTS.

## **9. Limitation of Liability**

TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE OPERATOR SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, OR ANY LOSS OF PROFITS, REVENUE, DATA, OR GOODWILL, ARISING OUT OF OR IN CONNECTION WITH THE USE OF OR INABILITY TO USE THE SERVICE, EVEN IF THE OPERATOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

THE OPERATOR ACCEPTS NO RESPONSIBILITY FOR THE CONTENT OF ANY URL SHORTENED THROUGH THE SERVICE.

## **10. Amendments**

The Operator reserves the right to amend these Terms at any time. Amended Terms will be published on the Service with an updated effective date. Continued use of the Service following publication of amended Terms constitutes the User's acceptance of such amendments.

## **11. Governing Law and Jurisdiction**

These Terms shall be governed by and construed in accordance with applicable law. Any disputes arising out of or in connection with these Terms shall be subject to the exclusive jurisdiction of the competent courts.
